NOTICE TO EXHIBITORS

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the Show Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

SURRENDER OF IDENTIFICATION CARD must be made to the check clerk when requested, for removing dogs from the show.

ALL GROOMING AND JUDGING WILL BE INDOORS.

NO GASOLINE OR DIESEL GENERATORS are permitted inside any building or within 100 feet of any tent in which a dog show is conducted.

AKC states only dogs eligible to be entered in the show (AKC registered Yorkies at least 4 months of age) may be in show area. We will enforce this rule. **NO PUPPIES FOR SALE.**

FROM THE AIRPORT:

PHILADELPHIA INT'L AIRPORT (PHL): I-95 N to I-476 N to I-76 W. Exit 298. After tolls, exit 1B, Rt 10 S Morgantown. ½ mile to 1st light. Right at light. Hotel is behind McDonald's.

READING AIRPORT (RDG): Right on Rt 183. Left on Rt 222 S. Take 422 E 5 miles to I-176 S. Take Exit 1. At end of Ramp, turn right on Rt 10 S. ½ mile. Hotel is on right, located behind McDonald's.

CHESTER COUNTY AIRPORT (MQS): Rt 10 S to Rt 30 E.

FROM THE NORTH: US 222 S to US 422 E to I-176 S. Exit 1. Right at end of ramp, Hotel half mile on right.

FROM THE SOUTH: PA Rt 10 N to Morgantown.

FROM THE EAST: PA Turnpike to Exit 298. After toll booth, take second right Morgantown exit. Make right onto Morgantown Rd. Follow half mile to hotel on right.
