NOTE: Novice, Amateur Owner Handler, Stud Dog, Brood Bitch, Brace Classes will NOT be offered.

***Bred-by-Exhibitor (BBE) Class** will be for dogs individually registered with AKC and must be shown by the breeder and owner of record. This class is divided into two age groups consisting of Puppy, for dogs that are six months of age but under twelve months, and Adult, for dogs that are twelve months of age and older. In any subsequent classes for which a dog from the Bred-by-Exhibitor class or divisions of it becomes eligible, there are no restrictions as to who may handle. Winners from the BBE Class will be counted toward the AKC BBE medallion. In addition, the Puppy division of the BBE class will be added to the list of classes in which points toward the AKC Puppy of Achievement Certificate may be earned.

(Additional Classes Involving single dog entries)

Veteran Dog Class will be for Dogs 7 years old and over. 1st place Dog will compete in BOB.

Veteran Bitch Class will be for Bitches 7 years old and over. 1st place Bitch will compete in BOB.

The club has elected to allow neutered dogs or spayed bitches to compete in Veteran classes.

BEST OF BREED COMPETITION

The Judge will award up to 4 Awards of Merit and Select Dog/Bitch following Best of Breed Judging.

AKC NATIONAL OWNER-HANDLED SERIES COMPETITION

Must be owner-handled by a non-professional handler. Must be marked on entry form at time of entry. Follows Best of Breed Judging.

BEST IN BRED-BY-EXHIBITOR will be held following the Best of Breed competition of each of the Shows. 1st place Dogs & Bitches from the BBE classes or divisions will compete.

BEST PUPPY IN SHOW will be held following the Best of Breed competition of each of the Shows. 1st place Dogs & Bitches from the Puppy classes (Puppy 6-<12 mo.) or divisions (BBE Puppy) will compete.

FOUR-TO-SIX MONTH (Beginner Puppy) COMPETITION

Must be handled by a non-professional handler. AKC Registration OR Litter Number. Exhibitors should open their dog's mouth for examination. Males with undescended testicles need NOT be excused but CM points will be withheld. No taping, gluing or stitching allowed in the ring. Class NOT divided by sex.

Parade of Champions, Title Holders, Veterans, Rescues (Non-Competitive)

Dogs entered in this class need not be entered in a Regular Class. This class will not be judged. Cut downs welcome. A history of the dog, limited to 50 words (show committee reserves the right to edit) is required. Each dog will receive a ROSETTE IMPRINTED with his/her name.

The person accompanying a dog must show tickets of admission and identification before the dog will be received. **Should such acknowledgement not be received by the exhibitor** within a reasonable time, please notify the Show Secretary.

Show Secretary assumes no responsibility for cash sent through the mail. Tabulate carefully. Due to cost of processing, no refunds of \$4.00 and under will be made.

AKC Event Service and Recording Fees will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These Event Service and Recording Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, these Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snowstorms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Post Dated Checks and Returned Checks do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

An Administrative Fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.

Errors on Entry Blanks: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Dogs May Arrive any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising area.

Class Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Show Secretary's Office advised at once. The Show Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

(Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.
